#### 1. Call to Order

City Chair Jim McShane (City AHAC) called the meeting to order at 10:07 a.m. There was quorum for both the City and the County AHACs.

Jim McShane, City AHAC Chair, requested a motion to approve the minutes from the March 21, 2022, and June 20, 2022, joint meetings.

#### 5. Presentations

#### 5.1 - City and County Draft 2022 Reports of Recommendations

Shington Lamy, Director of LC Human Services & Community Partnerships, reported that the County AHAC approved to maintain their current practices for items already listed under statutes and items approved at today's joint meeting will also be included in the report of recommendations that the County will develop.

Jean Amison, Housing Manager, reported that the City AHAC had two recommendations; one was to develop a Planned Unit Development (PUD) that is zoned and ready for developers to build on in a tract or on various parcels of City owned land. The second is for the innovation and education to landlords on code issues and unit upkeep to make rentals better in the City. Ms. Amison concurred with Mr. Lamy regarding any recommendations that stemmed from today's joint meeting will also be included in the City's report of recommendations.

There were no questions or comments on the 2022 Reports of Recommendations.

#### 6. Policy and Direction

#### 6.1 Update on Amended Inclusionary Housing Ordinance - City/County Staff

Mr. Lamy discussed the County/City Commission joint affordable housing workshop that took place in February 2022. The joint AHAC recommendation to develop a uniform IH ordinances within the urban service area, was presented to the County/City Commission. Once approved by the County/City Commission, the County worked with FHC and provided a few preliminary recommendations. Ashon Nesbitt with FHC presented recommendations and discussed IHO policy updates.

Kyndra Light motioned for staff to create language/update policy to develop a fund with Blueprint or other funding sources so when a developer chooses to opt into inclusionary housing there is a fund that pays to offset the additional infrastructure costs.

Mr. Lamy mentioned that further discussion will take place regarding the uniform IH ordinance, which will include the recommendation of a funding source for addressing the infrastructure cost as it relates to density bonuses. Updates will be provided during the next joint AHAC meeting in 2023.

#### **Public comment:**

Jason Ghazvini provided comment regarding a sliding scale with different levels; provide more subsidy for areas of highest selection; creation of affordable rentals; incentives, higher DPA; the need for Lenders to be involved.
