April 17, 2023 Meeting Summary Smith-Williams Service Center, 2295 Pasco Street

<u>Members in Attendance</u>: Mr. Chris Daniels, Mrs. Shari Gewanter, Mr. Jesse Jones, Commissioner Curtis Richardson, Mrs. Kyndra Light, Mr. Karlus Henry,

Staff: Jean Amison (Housing Manager), Dr. Kimball Thomas (HCR Director), Amy Toman (City Attorney)

<u>Call to Order, Welcome and Introductions:</u> The meeting was called to order at 10:18am. A quorum was declared.

Ms. Jean Amison, Housing Manager, updated the committee on the membership changes that had occurred since the last meeting. There were two reappointments by the City Commission in February, Ms. Mechelle Mickles and Mr. Jesse Jones were both reappointed to their current seats. However, Mr. Bill Wilson, representative of a For-Profit Developer, was not reappointed by the Commission as his term had expired. Mr. Christian Griffiths was appointed for that seat in February but was unable to attend the meeting today.

Because Mr. Wilson had vacated his seat, his term as Chair of the AHAC was also vacated. As such, new officers were needed. Ms. Amison called for nominations for Chair. Mr. Chris Daniels was nominated as Chair, Ms. Kyndra Light seconded, motion passed unanimously.

Mr. Daniels moved to accept nominations for Vice Chair and Secretary. Mrs. Light was nominated for Vice-Chair, motion seconded, and passed unanimously. Mr. Jones nominated himself for Secretary, motion seconded, and passed unanimously. The Officers for the 2023 AHAC are:

Mr. Chris Daniels, Chair Mrs. Kyndra Light, Vice Chair Mr. Jesse Jones, Secretary

<u>Public Comment:</u> One member from the Capital Area Justice Ministry requested to hold their public comment until after the presentation on the HUD Annual Action Plan. Ms. Amy Toman, City Attorney, approved. Public comment was held. There were no others present to make public comment at this time.

<u>Agenda Modifications</u>: There was one modification to the agenda. Item number 5.2, update on the LMI unit production and initiatives was removed. The addition of that item was in error. It referred to an item the County was to bring before the joint AHAC's from the meeting in March. However, that meeting was cancelled, and the item was discarded. There were no further modifications.

<u>Approval of the Minutes</u>: Commissioner Curtis Richardson moved approval of the minutes with any necessary corrections, Mr. Jones seconded the motion to approve the meeting minutes from the January 9, 2023, meeting. The motion passed unanimously.

<u>Presentations</u>: Mrs. Amison presented the FY2024 HUD Annual Action Plan to solicit feedback directly from the Committee in the crafting of the plan. This presentation was done before the City drafted the plan in preparation for the upcoming presentation of the draft plan to the City Commission. The full text and accompanying PowerPoint slides are available and will be attached to the packet for this meeting.

After the presentation, a member of the Committee asked what the amount of increase in state funding was. Mrs. Amison provided the current year's SHIP funding at \$1.9M, which was an increase over the prior year's allocation of \$1.3M, and for the coming year we expect the SHIP award to be \$2.3M. There was also a question about other funding provided in the new Live Local Act bill that was to be signed into law by the Governor. There had not been any other information about programs that would be funded other than SHIP; however, Mrs. Amison provided information on an upcoming webinar about the Live Local Act that is free to participants through the Florida Housing Coalition.

Comm. Richardson asked about the amount of funding the City puts towards affordable housing, as well as the County's allocation to affordable housing. Mrs. Amison gave a rough estimate on what we allocate annually according to our plan but deferred to the County for a response on their allocations. He also wanted the information on how much funding from the Neighborhood First Plans went into housing programs. Staff responded that we would get that information and provide it through ACM Ojetayo's office for a formal response to the Commissioner and the AHAC.

Rev. Sylvia Jones representing the Capital Area Justice Ministry provided public comments related to the HUD Annual Plan. She provided comment on the lack of specific objectives in the Annual and Consolidated Plans to address the construction of rental housing for very low and extremely low-income households. CAJM's comments included requests of the City to establish a new incentive financing program to increase the number of rental units constructed for those below 30% AMI and 50% AMI, to allocated \$5M per year to a trust fund specifically for construction of units for this population and seed the trust fund with \$12M to start. Mrs. Amison collected the comments to put with the Annual Plan submission.

Mrs. Shari Gewanter commented that she is concerned about how the City is reaching out to and supporting the homeless population in Tallahassee that seems to be growing. She stated that supporting low-income housing in addition to supporting affordable housing specifically for the homeless population is something the City should be doing. She commented that everything possible that we can do to prevent people from being homeless or being on the edge should be a priority. She also commented that this committee does not focus much on mental health but that she knows there are agencies working towards ending homelessness and addressing mental health needs.

Comm. Richardson clarified a comment that was made about Commissioners from the City and County supporting CAJM's requests/recommendations and that he did not support the seed of \$12M which would result in cuts to other services or an increase in taxes. It's why he wanted to know how much the City and County are already investing year over year in providing affordable housing which could be more than \$5M already.

With no further discussion, the presentation was ended, and comments closed.

Policy and Direction:

There were no Committee items in Policy and Direction.

Announcements:

Mrs. Amison went over the remaining 2023 AHAC meeting schedule.

Unagendaed Items:

During unagendaed items, members discussed taking applications for any vacant seats on the City's AHAC. Mrs. Amison commented there is one vacancy and that applications are taken year-round and held for a period of time if the applicant does not meet the criteria for the open seat.

The Committee also asked for the full City budget. Mrs. Amison indicated staff would provide the link to the City's budget page for their review.

Adjournment: After no further business, the meeting adjourned at 10:59 AM.
