## Air Carrier Incentive Program

Tallahassee International Airport (TLH) is committed to the development of successful air service partnerships in an effort to increase the availability of flight options. The incentives provided under the terms of this program are only available to those air carriers or public charter operators certificated under the requirements of Title 14 CFR Parts 121 or 135.

### New Domestic Air Service:

New non-stop service to any of the following destinations must be publicly announced by the carrier and verified by the Airport by January 31, 2023.

Boston – BOS	Chicago – MDW/ORD	Denver – DEN	Houston – IAH/HOU
Las Vegas – LAS	Nashville – BNA	New York City – JFK/LGA	Newark – EWR
Philadelphia – PHL	Syracuse – SYR	Washington DC – IAD/BWI

## New International Air Service:

All fees and charges are waived for new non-stop international service from any destination that is publicly announced and verified by the Airport by January 31, 2023.

Under this program, fee reductions and additional support would be available as follows:

### All Carriers:

<b>Landing Fees</b>	Waived for two years
<b>Passenger Security Charge</b>	Waived for two years
<b>Marketing Assistance</b>	Up to \$40,000
<b>Monthly Facility Fee Credit</b>	Waived for two years

- Note: 1) Additional community incentive packages may be available.  
2) The Airport Director may terminate the incentive package if the airline does not maintain a minimum 75% on-time performance each month.
