The conference is an opportunity for staff to learn and grow while sharing the great things that we are doing here in Tallahassee, especially projects that the CRA has funded.

#### Tourist Development Tax (TDT) Art, Heritage, and Culture Funding

The application window has closed for funding of up to \$2,000,000 in Tourist Development Tax (TDT) dollars available to eligible not-for-profits via the Leon County Commission, Visit Tallahassee, and the City of Tallahassee.

The application process is being administered by the Community Redevelopment Agency (CRA). The minimum award amount is \$500,000 and maximum award amount is up to Two Million Dollars (\$2,000,000) which may be awarded to a single applicant or multiple applicants. The proposed program or project must be located in one of Tallahassee's two CRA districts, the Greater Frenchtown/Southside District, or the Downtown District.

The following three (3) applications were deemed eligible for scoring:

- The Challenger Learning Center, Funding Request \$713,450
- Indaba, Inc., Funding Request \$1,000,000
- LeMoyne Arts Foundation, Inc., Funding Request \$765,000.

The applications will be further reviewed and scored during a public scoring meeting scheduled for Thursday, January 19, 2023, 9:00 AM - Noon, Smith-Williams Center, 2295 Pasco Street, Annex B. Final determination regarding funding lies with the CRA Board, City Commission, and County Commission. Stay tuned for more information!

### **GREATER FRENCHTOWN/SOUTHSIDE (GFS)**

### Business Facility Improvement Program (BFIP) Grant for 1215 S. Monroe St, Orion Weddington

Thursday, September 8, 2022, the CRA Board approved the application for grant funds in the amount of \$50,000 for façade and site improvements to the property located at 1215 S. Monroe Street. The owner is Orion Weddington, and the application was submitted by Christina Youman with Oliver Sperry Renovations as the owner's agent.

The total project cost for redevelopment of the building and site is \$466,690. The improvements include, but are not limited to, complete exterior façade renovation, storefront glass with design elements including awnings and roofing system, new American with Disabilities Act (ADA) stairs and side ramp, decorative metal railings with painted block and stucco finish.

### **DOWNTOWN DISTRICT (DT)**

#### "The Studios at LeMoyne", - Art for Always (AfA) Project Funded

On November 10, 2022, the CRA Board unanimously approved the \$100,000 funding request made by LeMoyne Art Foundation, "The Studios at LeMoyne", – Art for Always (AfA) project, a multi-phased art campus located at 415 – 425 E. Call Street/125 N. Gadsden Street.

The request was for 25% of the total project cost for this phase, which is estimated at \$400,000. The total project cost is \$3,200,000 and the applicant had raised \$2,472,042 to date of the CRA Board Meeting submission.

CRA staff reported to the CRA Board that the project is consistent with the DT Redevelopment Plan. The project will aid with more ongoing special events, activities and promotions for arts, culture, and heritage in the area. It is anticipated to assist with the need for housing downtown as well.

On October 10, 2022, the Downtown Redevelopment Commission (DRC) met and unanimously recommended that the CRA Board approve \$100,000 for the project.
